

Proposed Amendments - Current vs New Constitution

Please note the below is a summary of major / substantive changes to the Current Constitution under the Proposed Amendments only and it does not include minor amendments proposed which have relatively limited substantive effect. The table is intended to be viewed as a supplementary guide for members to contemplate and navigate the changes to the Constitution discussed with reference to and using the New Constitution, the Current Constitution marked-up to show the Proposed Amendments and the Explanatory Notes included in the Notice of Annual General Meeting.

Members should note that changes to the Current Constitution have been arranged into three categories:

- (a) **Deletions**: Rules or sections which have been removed entirely;
- (b) Additions: Rules which have been newly introduced;
- (c) **Amendments**: Rules which may have been amended or significantly altered by way of revision, addition or deletion.
