

## **Spring Home Loan Promotion Terms & Conditions**

- 1. 'Member' means the primary (first named) home loan borrower.
- 2. Employees (and their immediate families) of the Promoter, and agencies associated with this promotion are ineligible to enter
- 3. The promotion commences at 12.01am (AEST) on 18 September 2017 and closes at 11.59pm (AEDT) on 14 February 2018 (**Promotion Period**).
- 4. To enter and to be eligible to win a prize during the Entry Period;
  - Existing Australian Military Bank mortgage loan members must increase their existing eligible loan borrowings by \$150,000 or more; or
  - b. New Australian Military Bank customers must apply for a qualifying home loan with a value equal to or greater than \$150,000.

Eligible Entrants will then automatically receive one entry in this promotion. A qualifying home loan must be fully funded by 14 February 2018. In the case of new Construction Loans (which must be \$150,000 or more) at least the land value must have funded by 14 February 2018 (**Qualifying Entries**).

- 5. A maximum of one entry will be accepted per member. If there is more than one applicant named on the loan, only one entry will be accepted for that loan. Further if a member funds more than one loan over the Promotion Period, only one entry will be accepted for that member.
- There will be 8 prizes in total and 8 draws. The draws will be conducted at MDSA, 15 Grosvenor Street, Neutral Bay NSW 2089 at 2pm (AEDT) on 2 March 2018.



7. Major Prize Draw – the first eligible entry drawn from all Qualifying Entries will have the first year of their mortgage paid by Australian Military Bank, up to a maximum value of \$50,000.

The lump sum payment will be credited to the winner's eligible home loan within 28 days of the draw. If the Major Prize winner has multiple eligible loans, the lump sum payment will be calculated and paid against the home loan with the smallest approved loan limit.
