Things you need to consider

When you rollover your superannuation from one fund (old fund) to another fund (new fund), your entitlements under the old fund may cease. You need to consider all relevant information before you make a decision to roll over your superannuation. If you ask for information, your superannuation provider must give it to you. Some of the things you may consider are:

- Fees your old fund(s) must give you information about any exit or withdrawal fees. If you are not aware of the fees that may apply, you should contact your old fund(s) for further information before completing this form. Our Capital Guaranteed Super/Pension does not charge any entry fees on your rollover.
- Death and disability benefits Your old fund(s) may have insurance benefits such as death benefit, total and permanent disability cover and/or income protection. . If you choose to leave your old fund(s), you may lose some or all personal insurances entitlements you have. We recommend you obtain financial advice or seek professional advice before requesting the rollover

Using this form to rollover your superannuation will not change the fund to which your employer pays your contributions and may close the account you are transferring your superannuation from.
